## 2025 NCBA DIII League Participation Agreement – Renewal (Registration NLT June 1, 2024)

This League Participation Agreement ("Agreement") is by and between the Undersigned College or University Club Baseball Team ("Team") and the National Club Baseball Association ("NCBA").

The undersigned Team hereby agrees to participate in the NCBA's 2024/2025 Division III season upon the terms and conditions contained in this Agreement. The Team agrees that it will adhere to all NCBA DIII rules and regulations, including, but not limited to, the payment of the NCBA 2024/2025 DIII annual dues in the amount of \$1,680.00, which shall be due and payable no later than February 28, 2025. Annual dues for the 2024/2025 DIII season shall be discounted to \$1,580.00 if paid in full by the Team on or before December 1, 2024. The Team understands that the annual dues are non-refundable. The Team further understands and agrees that all accounts or monies due to NCBA shall be paid in accordance with the Credit Terms stated above, and agrees to pay all reasonable cost of collection, in addition to any court cost and/or attorney fees incurred in collection.

The Team further understands that it is responsible for ensuring that all team players individually complete the online NCBA DIII Player Registration, and agrees to submit a signed academic eligibility letter for all team players to the NCBA prior to participating in any NCBA sanctioned baseball games.

In consideration of the Team's agreement to be bound by the terms of this League Participation Agreement and the NCBA DIII rules and regulations, the NCBA hereby agrees to provide the following benefits and services to the Team throughout the term of the NCBA 2024/2025 DIII season:

- 1) Official recognition as a member of the National Club Baseball Association Division III;
- 2) Scheduling of a regular season conference schedule of games;
- 3) Opportunity to compete for the right to participate in National Postseason play;
- 4) Full access to the Official NCBA website (<u>https://div3.clubbaseball.org/</u>) for the purpose of tracking rosters, player stats, player bios, team records, conference standings, team website access, and team contact information;
- 5) Participation in the Official NCBA Fundraising Programs;
- 6) Pre-paid delivery of 5 Dozen Official NCBA game balls;
- 7) Pre-paid delivery of 1 BBCOR Certified Baseball Bat
- 8) Team coverage under an NCBA premium pre-paid general liability insurance policy;
- 9) Participation in the benefits of all Official NCBA Sponsorship programs and
- 10) Opportunity to obtain Official NCBA Consultation on club baseball program management and marketing plans.
